## **PROVINCIAL RESOLUTION NO. 129-2019**

**AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING BETWEEN AND AMONG THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS AND METROPOLITAN MANILA DEVELOPMENT AUTHORITY IN CONNECTION WITH THE DONATION OF THE OLD AND REUSABLE STRUCTURES OF THE ESTRELLA-PANTALEON BRIDGE TO THE PROVINCE OF PANGASINAN**

**WHEREAS**, the “Build, Build, Build” is a flagship infrastructure development program of the present administration that aims to rehabilitate and upgrade old bridges in the country;

**WHEREAS**, the Estrella-Pantaleon Bridge, also known as Rockwell Bridge, which connects the Cities of Makati and Mandaluyong is scheduled to be dismantled and repaired soon;

**WHEREAS**, the utilization of the structures from the Estrella-Pantaleon Bridge to build new bridges in other regions of the country is an alternative scheme;

**WHEREAS**, at present, the only means of transportation of the people in going to the barangays of Santiago Island is through a barge which goes to the island only four times a day;

**WHEREAS**, the Provincial Government of Pangasinan has sought the assistance of the Department of Public Works and Highways and the Metropolitan Manila Development Authority for the construction of the bridge in Santiago Island in Bolinao, Pangasinan using the structures of the Estrella-Pantaleon Bridge;

**WHEREAS**, this alternative scheme will hasten the construction of the Santiago Bridge and will enable the government to save funds for a new bridge;


