APPROVING RESOLUTION NO. 52, S-2019 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED "AMENDING RESOLUTION NO. 159, S-2018, ALSO KNOWN AS "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 CY 2018 OF THE MUNICIPALITY OF MAPANDAN" AND DECLARING TO THE EFFECT AS SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 OF THE MUNICIPALITY OF MAPANDAN, PANGASINAN OF THE IMPROVEMENT/EXTENSION OF PUBLIC MARKET AT BARANGAY POBLACION AND CONSTRUCTION OF MOTORPOOL AND RC WALL FENCE AT THE BACK OF THE MUNICIPAL ABATTOIR IN THE AMOUNT OF TWENTY-EIGHT MILLION FIVE HUNDRED THOUSAND PESOS (P28,500,000.00)"

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Resolution No. 52, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Mapandan, Pangasinan has prepared the municipality's Supplemental Annual Investment Program for CY 2019. This was endorsed by the Council thru MDC Resolution No. 05, S-2019 dated October 23, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 52, S-2019 dated November 28, 2019;

WHEREAS, based on SB Resolution No. 52, S-2019, the reason of change in project titles was due to strong opposition of the barangay residents and the legal findings of DENR on the previously proposed projects;

WHEREAS, funding support for the Supplemental AIP No. 2 is embodied in Supplemental Budget No. 2, CY 2019 of the LGU, and enacted by the Sangguniang Bayan through Appropriation Ordinance No. 4, S-2019 dated December 16, 2019;

WHEREAS, however, since the projects will be funded by a loan from the Land Bank of the Philippines, changes in project titles should be properly coordinated with the said bank;
