#### **RESOLUTION NO. 129-2021**

APPROVING RESOLUTION NO. 116, S-2020 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2021 OF THE MUNICIPALITY OF INFANTA, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Infanta, Pangasinan submitted its Resolution No. 116, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Infanta, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for Calendar Year 2021. This was endorsed by the Local Development Council to the Sangguniang Bayan on September 21, 2020 through MDC Resolution No. 6, S-2020;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Infanta, Pangasinan was formulated following the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operations of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the

20% development fund, c) Disaster Risk Reduction programs, projects and activities, d) Local Climate Change Action Plan, e) Peace and Order Plan, f) Gender and Development Plan, g) Annual Procurement Plan, h) Culture and Arts Development Plan, i) Nutrition Action Plan, and j) List of Programs/Projects/Activities (PPAs) for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities, PPAs to combat the Acquired Immune Deficiency Syndrome and PPAs to address the problems on illegal drugs;

WHEREAS, the proposed AIP of Infanta for CY 2021 has an investment requirement of P172,205,957.00. Funding support for the implementation of which is embodied in their 2021 proposed Annual Budget in the amount of P157,405,957.00, which was passed and approved by their Sangguniang Bayan on October 27, 2020 through Appropriation Ordinance No. 6, S-2020. The remaining P14,800,000.00 will be funded from the following sources: Capitation Fund (P1,650,000.00), Local School Board Fund (P1,150,000.00) and Local Government Support Fund-Assistance to Municipalities (P12,000,000.00);

WHEREAS, this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGU's IRA (P138,557,957.00), which is equivalent to P27,711,591.40 is allocated for development projects. These development programs/projects conform to the Joint DBM-DOF-DILG Memorandum Circular No. 1, dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects);

WHEREAS, the integrated Disaster Risk Reduction and Management Plan in preparation for and to mitigate the impact of disasters to be funded by the 5% LDRRM Fund (P7,259,797.85), is in conformity to Section 21 of RA 10121. The programs, projects and activities to be funded by 70% of the 5% LDRRM Fund in the amount of P5,081,858.50 were based on NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of the Interior and Local Government (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). Further, the LDRRM Plan of the municipality was submitted to the Office of Civil Defense for review;

**WHEREAS**, the LGU of Infanta had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Programs, Projects and Activities (GAD-PPAs) attached were reviewed by the Department of Interior and Local Government (DILG) Regional Office, and were found to be in conformity with the provisions of the DBM, PCW, DILG & NEDA Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women;
