DECLARING ORDINANCE NO. 168, S-2021 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING TWENTY FIVE (25) PLANTILLA POSITIONS UNDER THE DIFFERENT OFFICES OF THE LOCAL GOVERNMENT UNIT OF BASISTA, PANGASINAN, DEFINING THE DUTIES AND FUNCTIONS AND PROVIDING FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 168, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
