DECLARING MUNICIPAL ORDINANCE NO. 06, S-2017 OF SANGGUNIANG **BAYAN** INFANTA. PANGASINAN, **ENTITLED** "AN **ORDINANCE** PROMULGATING THE GENDER AND DEVELOPMENT CODE OF THE MUNICIPALITY OF INFANTA. PANGASINAN AND FOR OTHER PURPOSES" AS THE CONFERRED **POWERS** THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Municipal Ordinance No. 06, Series of 2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted in line with national policies and principles of the Gender and Development Code enshrined in the 1987 Philippine Constitution as well as the Gender and Development Code of the Province of Pangasinan; RA 7192 (An Act Promoting the Integration of Women as Full and Equal Partners of Men in Development and Nation Building and For Other Purposes); and Section 17 (a) (iv) of RA 7160;
