RESOLUTION NO. 133-2019

DECLARING ORDINANCE NO. 17-14 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "AN ORDINANCE REVISING CITY ORDINANCE NO. 02-11 OTHERWISE KNOWN AS THE "2011 INVESTMENTS AND INCENTIVES CODE OF THE CITY OF SAN CARLOS (PANGASINAN)" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 17-14 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16, 109 (a) (1), (2), (3), (4) (5) and (6); 192 and 458 (a) (2) (ii) and (xii) of RA 7160; RA No. 7042 (Foreign Investment Act of 1991); RA No. 7844 (Export Development Act of 1994) and RA No. 7916 (Special Economic and Zone Act of 1995);

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with all the requirements set forth in Sections 59 (c) and 511 (a) of RA 7160;


