**APPROVING RESOLUTION NO. 2021-285 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 7, CY 2021 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2021-285 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Municipal Development Council Executive Committee of Mangaldan, Pangasinan prepared their Supplemental Annual Investment Program (SAIP) No. 7 for CY 2021; This was endorsed to the Sangguniang Bayan for approval on December 27, 2021 through MDC Resolution No. 6, Series of 2021;

**WHEREAS**, said Supplemental AIP which has total investment requirement of P10,000,000.00 covers the implementation of various development projects of the LGU;

**WHEREAS**, funding for the Supplemental AIP will be sourced from the realignment/reversion of funds from the Unexpended Appropriation for Purchase of COVID-19 vaccines of the LGU as embodied in their Supplemental Budget No. 6, FY 2021, which was enacted by their Sangguniang Bayan on December 27, 2021 through Appropriation Ordinance No. 2021-27;


