RESOLUTION NO. 137-2019

DECLARING ORDINANCE NO. 07-2018 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "AN ORDINANCE SUPPLEMENTING ORDINANCE NO. 08-2017, OTHERWISE KNOWN AS "ORDINANCE APPROVING THE MARKET CODE OF THE MUNICIPALITY OF ROSALES, PROVINCE OF PANGASINAN" BY ADDING LIST OF MARKET STALLS COMPRISING THE NEW FOOD COURT AREA IN THE PUBLIC MARKET AND ITS CORRESPONDING RENTAL FEES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Ordinance No. 07-2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the power of the Sanggunian to enact ordinance and approve resolutions carries with it the power to amend, revoke, modify or repeal the same;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with all the legal requirements of Sections 187 and 188 of RA 7160;
