APPROVING RESOLUTION NO. 2021-287 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 8, CY 2021 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2021-287 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Municipal Development Council-Executive Committee of Mangaldan, Pangasinan prepared their Supplemental Annual Investment Program (SAIP) No. 8 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on December 27, 2021 through MDC Resolution No. 7, Series of 2021;

WHEREAS, said Supplemental Annual Investment Program, which has a total investment requirement of P2,120,000.00, covers the the granting of Service Recognition Incentive (SRI) to qualified personnel of the LGU;

WHEREAS, funding for the Supplemental AIP will be sourced from the savings of the LGU as embodied in their Supplemental Budget No. 7, FY 2021, which was enacted by their Sangguniang Bayan on December 27, 2021 through Appropriation Ordinance No. 2021-28;


