PROVINCIAL RESOLUTION NO. 139-2020

EXPRESSING THE SENTIMENTS OF THE SANGGUNIANG PANLALAWIGAN TOWARDS THE POSSIBLE POSTPONEMENT OF THE HOLDING OF THE 2020 REGION 1 ATHLETIC ASSOCIATION (R1AA) MEET IN THE PROVINCE OF PANGASINAN

WHEREAS, the holding of the 2020 Region 1 Athletic Association (R1AA) Meet is set to be held on February 19-26, 2020 in the Province of Pangasinan;

WHEREAS, the R1AA shall be hosted by the Schools Division Office – Pangasinan I under the leadership of the Officer-in-Charge, Schools Division Superintendent, Dr. Sheila Marie D. Primicias;

WHEREAS, there are reports of cancellation of some important events in other areas and one of which is the Cordillera Administrative Region Athletic Association Meet;

WHEREAS, the Province of Pangasinan will be expecting thousands of delegates from the different schools divisions in Region 1 and no less than the Department of Health has advised the public to avoid crowded places in order to reduce exposure to the acute respiratory disease;

WHEREAS, at present, the Department of Health has reported an increase in the number of persons under investigation (PUI) for the nCoV and the Sangguniang Panlalawigan would like to ensure the health and safety of every individual, especially the students-athletes who will be participating in the said Meet;

WHEREAS, one of the precautionary measures that the Province would like to be adopted is the possible postponement of the 2020 R1AA Meet in view of the confirmed cases of nCoV in the country;

WHEREFORE, on motion of SP Members Von Mark R. Mendoza and Jeremy Agerico B. Rosario, duly seconded, it was –


