C E R T I F I C A T I O N

TO WHOM IT MAY CONCERN:

THIS IS TO CERTIFY that at the regular session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on July 20, 1992, at Lingayen, Pangasinan, the following Ordinance was approved:

PROVINCIAL ORDINANCE NO. 14-92

CREATING THE POSITIONS OF ONE (1) PROVINCIAL GOVERNMENT DEPARTMENT HEAD (PROVINCIAL ACCOUNTANT), ONE (1) PROVINCIAL GOVERNMENT ASSISTANT DEPARTMENT HEAD (ASST. PROVINCIAL ACCOUNTANT), AND ONE (1) DRIVER I IN THE OFFICE OF THE PROVINCIAL ACCOUNTANT

Be it enacted by the Sangguniang Panlalawigan in session assembled that:

SECTION 1 - The positions of one (1) Provincial Government Department Head (Provincial Accountant), one (1) Provincial Government Assistant Department Head (Asst. Provincial Accountant), and one (1) Driver I in the Office of the Provincial Accountant are hereby created;

SECTION 2 - Effective upon approval of the Sangguniang Panlalawigan corresponding salaries for the above-mentioned items in Section 1 of this Ordinance will be appropriated and included in the annual plantilla;

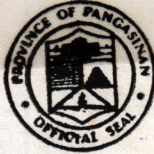
SECTION 3 - The initial salaries per month for the aforesaid positions created are as follows:

Provincial Accountant	- (G26)	- P12,650.00
Asst. Provincial Accountant	- (G24)	- 10,135.00
Driver I	- (G3)	- 2,156.00

SECTION 4 - The above-cited positions are urgently needed to perform the following duties, powers and responsibilities to wit:

- a) Provincial Accountant - He shall take charge of both the accounting and internal audit services of the Province and shall perform all others powers and duties as provided under Act, IV, Section 474, par. (b) of RA 7160 otherwise known as the Local Government Code of 1991;

- b) Asst. Provincial Accountant - He shall assist the Provincial Accountant and perform such other duties as maybe assigned to him;
- c) Driver I - To act as official driver and perform such other duties as maybe assigned to him by his superior.

SECTION 5 - EFFECTIVITY. This Ordinance shall take effect upon approval.
