APPROVING RESOLUTION NO. 2017-079 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 01, CY 2017 OF SUAL, PANGASINAN AMOUNTING TO TWENTY SEVEN MILLION EIGHT HUNDRED SIXTY THREE THOUSAND ONE HUNDRED TWENTY EIGHT PESOS AND 34/100 (P27,863,128.34)"

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2017-079 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council Executive Committee of Sual, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2017. This was endorsed to the Sangguniang Bayan for approval on September 11, 2017 thru MDC Executive Committee Resolution No. 01, S-2017 and was favorably acted upon by the Sangguniang Bayan on September 22, 2017 thru SB Resolution No. 2017-079;

WHEREAS, the Supplemental Investment Program No. 1 of the municipality covers the granting of salary increase and other benefits for the officials and employees and the implementation of developing project as well as disaster risk reduction activities;

WHEREAS, the development project proposed to be funded by the realigned 20% development fund is in accordance with the Joint DBM-DILG Memorandum Circular No. 2017-1, dated February 22, 2017 (“Updated Guidelines on the Appropriation and Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for Development Projects”);

WHEREAS, the Supplemental Investment Program has a total investment requirement of P28,863,128.34, of which P26,663,128.34 will be funded by Supplemental Budget No. 1, CY 2017 which was approved and enacted by their Sangguniang Bayan on September 22, 2017 thru Appropriation Ordinance No. 02 and the remaining amount of P2,200,000.00 is to be funded by the LDRRMF Special Trust Fund;

WHEREAS, it is noted, however, that the amount for the MOOE under the General and Other Services under SB Resolution No. 2017-079 and in this Supplemental AIP is only P736,260.00, which is P1,000,000.00 lesser compared to the Supplemental Budget No. 1, CY 2017 with an appropriation of P1,736,280.00. Clarification on this matter is respectfully recommended;

WHEREAS, the projects proposed to be funded by the LDRRMF Trust Fund are supportive to the disaster risk reduction and management activities of the LDRRMC based on the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013. However, in order for the LDRRMF Trust Fund to be fully utilized, Section 6.5 of the said JMC shall be observed;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Antonio F. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2017-079 of the Sangguniang Bayan of **Sual**, Pangasinan, entitled “Approving the Supplemental Investment Program (SIP) No. 01, CY 2017 of Sual, Pangasinan amounting to Twenty Seven Million Eight Hundred Sixty Three Thousand One Hundred Twenty Eight Pesos and 34/100 (P27,863,128.34)”;


