PROVINCIAL RESOLUTION NO. 14-2019

INVITING THE DEPARTMENT OF EDUCATION, PHILIPPINE NATIONAL POLICE, MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE OF MANGALDAN, PANGASINAN, AND THE PARENTS-TEACHERS ASSOCIATION FEDERATION PRESIDENT TO APPEAR BEFORE THE SANGGUNIANG PANLALAWIGAN DURING ITS JANUARY 28, 2019 REGULAR SESSION TO APPRISE THE AUGUST BODY ON THE INCIDENTS OF BULLYING IN THE PROVINCE AND THE PROGRAMS BEING UNDERTAKEN TO MITIGATE THE SAME

WHEREAS, the Sangguniang Panlalawigan is saddened over some news reports of bullying incidents in the Province of Pangasinan which led to the death of the victims;

WHEREAS, more often than not, bullying incidents happen in schools and it would be one of the things that the Department of Education, Philippine National Police and other relevant groups have been seriously looking into;

WHEREAS, the safety of the people of Pangasinan, more particularly the studentry is of paramount importance and it is also the concern of the Sangguniang Panlalawigan to protect them from untoward incidents such as bullying;

WHEREAS, the Sangguniang Panlalawigan in its desire to minimize, if not prevent, bullying in the Province of Pangasinan, is calling for the concerned authorities to address the incidents that had happened, heighten awareness and conduct productive discussions about the problem to ensure the protection of every individual to learn in a safe environment;


