#### PROVINCIAL RESOLUTION NO. 141-2020

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO, III, TO ENTER INTO A DEED OF USUFRUCT WITH THE PHILIPPINE NATIONAL POLICE MARITIME GROUP (PNP-MG) FOR THE USE OF TWO THOUSAND THREE HUNDRED FORTY SEVEN (2,347 SQ.M.) SQUARE METERS LOT IN SUAL, PANGASINAN FOR THE CONSTRUCTION OF ITS OFFICE AND BOATHOUSE

WHEREAS, the Philippine National Police Maritime Group (PNP-MG) has requested the Province of Pangasinan to donate a parcel of land occupied by the Sual Maritime Police Precinct situated at Barangay Poblacion East, Sual, Pangasinan for the construction of its office and boathouse to accommodate its High-Speed Tactical Watercraft;

WHEREAS, the Province is the registered owner of a parcel of land under Tax Declaration of Real Property with Technical Description No. 40-0001-01117, Property Identification No. 013-40-001-18-013 containing an area of, more or less, Seven Thousand Seven Hundred Seventy Six (7,776) square meters, situated in Barangay Poblacion, Sual, Pangasinan;

**WHEREAS,** the Province, recognizing the vital role of the PNP-MG in ensuring public safety and internal security over the Philippine territorial waters and rivers including ports of entry, hereby agrees to the gratuitous use of the property by the latter by way of usufruct instead of a donation;

**WHEREAS**, the term of the Usufruct shall be for twenty-five (25) years subject to early termination for just and valid cause, or renewal upon the discretion of both parties;
