WHEREAS, the Local Development Council of Pozorrubio, Pangasinan has identified items in their Supplemental Annual Investment Program No. 6 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on December 29, 2021 through MDC Resolution No. 07, Series of 2021;

**WHEREAS**, the Supplemental Investment Plan of the municipality covers fund augmentation for the provision of gratuity pay to Contract of Service and Job Order Workers of the municipality under Maintenance and Other Operating Expenses;
