WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 318-12312021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

WHEREAS, the Local Development Council of Pozorrubio, Pangasinan has identified items in their Supplemental Annual Investment Program No. 6 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on December 29, 2021 through MDC Resolution No. 07, Series of 2021;

WHEREAS, the Supplemental Investment Plan of the municipality covers fund augmentation for the provision of gratuity pay to Contract of Service and Job Order Workers of the municipality under Maintenance and Other Operating Expenses;
