**APPROVING RESOLUTION NO. 2020-254 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 7, CY 2020 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2020-254 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council-Executive Committee of Mangaldan, Pangasinan prepared their Supplemental Annual Investment Program (SAIP) No. 7 for CY 2020. This was endorsed by the Council, through MDC- Resolution No. 8, S-2020 dated December 29, 2020 to the Sangguniang Bayan for approval;

**WHEREAS**, said Supplemental AIP, which has a total investment requirement of P999,000.00, covers the granting of Gratuity Pay to Contract of Service and Job Order Workers of Mangaldan Municipal Government for Fiscal Year 2020;

**WHEREAS**, funding for the Supplemental AIP is embodied in their Supplemental Budget No. 7, FY 2020, and enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2020-12 dated December 29, 2020;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan;
