**DECLARING THE SUPPLEMENTAL BUDGET NO. 6 FOR
CALENDAR YEAR 2021 OF POZORRUBIO, PANGASINAN
INVOLVING A TOTAL APPROPRIATION OF P594,000.00,
OPERATIVE IN ITS ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Supplemental Budget No. 6 for Calendar Year 2021 involving total appropriations of P594,000.00, which was enacted on December 31, 2021 through Appropriation Ordinance No. 07-12312021;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 414 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That the grant of Gratuity Pay to Contract of Service and Job Order Workers in the municipality shall be in accordance with Administrative Order No. 46 of the Office of the President dated December 29, 2021; and
3. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2021 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007.
