APPROVING RESOLUTION NO. 89-2021 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, PANGASINAN, ENTITLED, “APPROVING/ADOPTING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 02 (SIP-02-SS-2021) OF THE MUNICIPALITY OF STO. TOMAS, PANGASINAN FOR CALENDAR YEAR 2021”

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Resolution No. 89-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Local Development Council of Sto. Tomas, Pangasinan has identified programs/projects to be funded from the municipality’s CY 2018 share from Tobacco Excise Tax. These are embodied in the municipality’s Supplemental Investment Program (SIP-02-SS-2021) which was endorsed to the Sangguniang Bayan for approval on November 23, 2021 through MDC Resolution No. 03-SS-2021;

WHEREAS, the Supplemental Investment Program No. 02 which has a total investment requirement amounting to P9,780,588.00 covers the implementation of development projects that are consistent with Local Budget Memorandum Nos. 83 and 84 both dated November 22, 2021;

WHEREAS, to support the implementation of the Supplemental Investment Program No. 02, the Sangguniang Bayan enacted Supplemental Budget No. 2, which was enacted by their Sangguniang Bayan on December 21, 2021 through Appropriation Ordinance No. 03, Series of 2021;


