WHEREAS, the Province of Pangasinan is steadfast in its support and good partnership with the Muslim Communities in the province to sustain their initiatives and advocacies;

WHEREAS, as early as August 2015, the intention to establish the Pangasinan Muslim Affairs and Consultative Council has been conveyed by the group convenor Datu Allan M. Maasir, to the province of Pangasinan;


