**RESOLUTION NO. 148-2020**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2019 OF ANDA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P2,485,000.00 OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Anda, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2019 involving total appropriations of **P2,485,000.00** which was approved on December 11, 2019 through Appropriation Ordinance No. 03, S-2019;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The grant of One-Time Service Recognition Incentive for FY 2019 for municipal officials and employees shall be in accordance with the provisions of Budget Circular No. 2019-6 dated December 9, 2019 of the Department of Budget and Management specifically Item 8.1 thereof;
2. The grant of Collective Negotiation Agreement (CNA) Incentive for FY 2019 to municipal officials and employees shall be subject to the provisions of Budget Circular No. 2019-5 of the Department of Budget and Management dated November 7, 2019; *and*

3. The funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of RA 7160 and Article 417 (a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993.

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN ITS ENTIRETY the Supplemental Budget No. 2 for Calendar Year 2019 of Anda, Pangasinan** as of the date fixed therein for its effectivity; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Anda;
