DEXTER R. BUTED AS SECOND TERM PRESIDENT OF THE PANGASINAN STATE UNIVERSITY AND ALL PERTINENT DOCUMENTS SUBMITTED IN SUPPORT THEREOF

WHEREAS, on November 26, 2018, the Sangguniang Panlalawigan approved Provincial Resolution No. 718-2018, entitled “Urging the Civil Service Commission through Chairperson Alicia Dela Rosa-Bala, Commissioner Leopoldo Roberto W. Valderosa, Jr., Assistant Commissioner David E. Cabanag, Jr. and Regional Director Hedy Jose B. 
