## PROVINCIAL RESOLUTION NO. 151-2019

INVITING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO DELIVER THE STATE OF THE PROVINCE ADDRESS BEFORE THE 9<sup>TH</sup> SANGGUNIANG PANLALAWIGAN ON ITS MARCH 22, 2019 SPECIAL SESSION

WHEREAS, Section 465 (iii) of RA 7160, otherwise known as the Local Government Code of 1991, mandates the governor to annually brief the sangguniang panlalawigan on the state of the province and to present the provincial government's programs and policies for the new calendar year;

WHEREAS, it is imperative that the 9th Sangguniang Panlalawigan be apprised of Honorable Governor Amado I. Espino III's policies, priority development plans, and programs for the Provincial Government to engender further an atmosphere for an effective and closely coordinated working relationship between the Province's executive and legislative bodies;
