PROVINCIAL ORDINANCE NO. 155-2011

AN ORDINANCE REPEALING PROVINCIAL ORDINANCE NO. 120-2005 ENTITLED "AN ORDINANCE CREATING A CAPITATION FUND TO SUPPORT THE PROVINCIAL GOVERNMENT'S HEALTH PROGRAM UNDER THE NATIONAL HEALTH INSURANCE PROGRAM (NHIP) OF THE PHILIPPINE HEALTH INSURANCE CORPORATION"

WHEREAS, Provincial Ordinance No. 120-2005 created the Philhealth Capitation Fund (PCF) to support the provincial government's health program under the National Health Insurance Program (NHIP) of the Philhealth;

WHEREAS, Philhealth Circular No. 16, Series of 2004, provides for the use of PCF and states that the following may be charged to this fund:

1. Drugs listed in the Philippine National Drug Formulary (PNDF);
2. Equipment and supplies necessary/related to carry out the delivery of the required services including but not limited to medical equipment and supplies, furniture and fixtures, appliances, office equipment, consumables and supplies;
3. Site improvement of health facility;
4. Referral fees for diagnostic services;
5. Administrative cost not exceeding 20% of the total PCF.

WHEREAS, there is a need to repeal Provincial Ordinance No. 120-2005 since it limits the use of the PCF to the procurement of drugs, medicines and contraceptives listed in the Philippine National Drug Formulary, and medical equipment and supplies needed by the provincial health program;

WHEREAS, the use of the Capitation Fund by the Province must now conform to the provisions stated in Philhealth Circular No. 16, Series of 2004;




Be it enacted by the Sangguniang Panlalawigan in session assembled that:


