PROVINCIAL RESOLUTION NO. 155-2019

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO SIGN A DEED OF DONATION AND ACCEPT A ONE HECTARE LOT IN BURGOS, PANGASINAN, COVERED BY TAX DECLARATION NO. 15-0011-11333

WHEREAS, the Cabiles Family is the owner of a parcel of land situated at Barangay San Vicente, Burgos, Pangasinan with a total area of 132,290 square meters, more or less, covered by Tax Declaration No. 15-0011-11333;

WHEREAS, in 2017, the Cabiles Family executed an Extrajudicial Settlement of Estate with Donation over a 2-hectare portion of the said real property with the Province of Pangasinan to where the Pangasinan Reformation Center has been built;

WHEREAS, the Cabiles Family would like to donate an additional one (1) hectare of their land property which is adjacent to the Pangasinan Reformation Center;

WHEREAS, the one (1) hectare lot shall be used primarily by the Province as a venue for the Provincial Livelihood and Disaster Risk Reduction and Management (DRRM) Training Center to cater to various livelihood programs of the Province especially in Western Pangasinan;

WHEREAS, the Center shall also serve as a satellite office of the Provincial Disaster Risk Reduction and Management Office as site for its capacity-building activities to address dynamics of disaster preparedness and climate change;
