**APPROVING SB RESOLUTION NO. 56, S-2021 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 04 CY 2021 OF THE MUNICIPALITY OF BANI, PANGASINAN FUNDED BY THE GENERAL FUND, MUNICIPAL DEVELOPMENT FUND AND DBM’S LGSF-FINANCIAL ASSISTANCE”**

**WHEREAS**, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 56, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Supplemental Investment Program No. 04 was endorsed by the Municipal Development Council to the Sangguniang Bayan for approval on October 26, 2021 through MDC Resolution No. 2021-09;

**WHEREAS**, subject Supplemental AIP covers fund augmentation for the Maintenance and Other Operating Expenses of some municipal offices and implementation of various COVID 19-related programs and projects, including the project to be funded from the realigned 20% development fund as contained in SB Resolution No. 55, S-2021;

**WHEREAS**, funding requirement for the implementation of this Supplemental Investment Program No. 04 in the amount of P14,000,000.00 is embodied in the proposed Supplemental Budget No. 04 CY 2021, which was enacted by the Sangguniang Bayan on November 2, 2021 through Appropriation Ordinance No. 05, S-2021 and approved by the Municipal Mayor on December 31, 2021;


