WHEREAS, the late former Mayor Antonio A. Villar, Jr., one of the respected political leaders of the Province of Pangasinan, has passed away to join his Creator last March 1, 2019 at the age of 72 due to a lingering illness;

WHEREAS, the late former Mayor Antonio A. Villar, Jr. is survived by his wife, former Mayor Vivien Villar, daughter, former Provincial Board Member Marie Antonnette Villar-Pescador, and grandchildren, Toni, Gari and Aljo;

WHEREAS, "Bebot", as he is fondly called by many, is a symbol of a vibrant leader and a strong pillar in the Municipality of Sto. Tomas having served as a Mayor for twenty-three (23) years from 1972 up to 1992, then again from 2001-2004, making him the longest-serving Mayor of the Province;

WHEREAS, the late former Mayor Antonio A. Villar, Jr. is revered not only by his fellow mayors and other local officials for his being a former President of the Pangasinan Mayors League but by private sectors as well, as he had also spearheaded some important groups, like the Philippine Jaycees during his younger years and as founding Chairman of *Biskeg* na Pangasinan, a group of political leaders in the Province who banded themselves together regardless of their political color and affiliation for the common good of their provincemates;
