APPROVING RESOLUTION NO. 81, S-2021 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN OF SUPPLEMENTAL BUDGET NO. 7 CY 2021"

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Resolution No. 81, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

WHEREAS, the Local Development Council of Aguilar, Pangasinan had identified items in their Supplemental Investment Program No. 7 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on December 30, 2021 through MDC Executive Committee Resolution No. 18, Series of 2021;

WHEREAS, the Supplemental Investment Program No. 7 covers fund augmentation for the Personal Services (gratuity pay for Job Orders and granting of Service Recognition Incentive to municipal officials and employees) and implementation of disaster risk reduction programs of the LGU;

WHEREAS, funding support for the implementation of the same in the amount of P1,242,550.00 is embodied in their proposed Supplemental Budget No. 7, CY 2021, which was enacted by the Sangguniang Bayan on December 31, 2021 through Appropriation Ordinance No. 07, Series of 2021;
