APPROVING SB RESOLUTION NO. 118-2020 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2021 OF THE MUNICIPALITY OF MALASIQUI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its SB Resolution No. 118-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that it is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Malasiqui, Pangasinan had identified and prioritized programs and projects in the Annual Investment Program for Calendar Year 2021. This was endorsed by the Council to the Sangguniang Bayan thru MDC Resolution No. 05, S-2020 dated October 9, 2020;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Malasiqui, Pangasinan was formulated following the prescribed AIP Summary Form and covers: a) all the regular budgetary requirements for

the operations of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction Management programs, projects and activities, and d) activities in pursuance of the objectives of GAD of the LGU. Also attached to the AIP, among others are the following: a) Local Climate Change Action Plan, CY 2021, b) list of programs/projects/activities for the Local Council for the Protection of Children CY 2021, c) list of programs/projects/activities for Senior Citizens and Persons with Disabilities CY 2021, d) Peace and Order Plan CY 2021, e) Annual Cultural Development Plan, and f) Nutrition Plan;

WHEREAS, the AIP of Malasiqui for CY 2021 has a total investment requirement of P406,437,712.45. Of this, the sum of P392,986,210.45 will be funded from the General fund and Tobacco Excise Tax Fund of the municipality as embodied in their Annual Budget for CY 2021, which was passed and approved by their Sangguniang Bayan through Appropriation Ordinance No. 003, S-2020 dated November 11, 2020. The remaining amount of P13,451,502.00 will be sourced from the Local Government Support Fund-Financial Assistance to Municipalities (LGSF-FA) of the National Government;

WHEREAS, 20% of the LGU's IRA (P322,958,649.00), amounting to P64,591,730.00 is allocated for development projects. This is in accordance with Section 287 of RA 7160;

WHEREAS, the development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs and projects included in the Municipal Disaster Risk Reduction and Management Plan, amounting to P18,114,432.45 were based on Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). The LDRRM Plan of the municipality has been submitted to the Office of Civil Defense-RO1 for review and evaluation;

WHEREAS, the Gender and Development Plan and Budget for CY 2021 of the municipality has been reviewed by the Department of Interior and Local Government (DILG) Provincial Office, and found to be fully compliant in form and in contents with the provisions of Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women;
