APPROVING RESOLUTION 251, S-2020 **OF** THE **SANGGUNIANG BAYAN OF** BAUTISTA, PANGASINAN, "ADOPTING THE **FORMULATED ENTITLED** INVESTMENT PROGRAM OF MUNICIPALITY OF BAUTISTA, PANGASINAN FOR CALENDAR YEAR 2021 UNDER MUNICIPAL **DEVELOPMENT COUNCIL RESOLUTION NO. 9, SERIES OF 2020** AMOUNTING TO ONE HUNDRED SIXTEEN MILLION NINE HUNDRED THIRTY SIX THOUSAND THREE HUNDRED FIFTY THREE PESOS (P116,936,353.00)"

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 251, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that it is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Bautista, Pangasinan had formulated the municipality's Annual Investment Program for Calendar Year 2021 and endorsed thru MDC Resolution No. 09, S-2020 dated August 13, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Bautista, Pangasinan was formulated following the

prescribed AIP Summary Form categorized into general public, social, economic and other services sectors and covers: a) all the regular budgetary requirements for the operations of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction Management programs, projects and activities of the municipality. It also includes the following: 1) Gender and Development Plan, Peace and Order Plan, Local Climate Change Action Plan, Nutrition Plan, Annual Procurement Plan and Annual Cultural Development Plan, and 2) list of programs/projects to address the problem on Illegal Drugs, combat Acquired Immune Deficiency Syndrome and for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities;

WHEREAS, the AIP is supported by the Annual Budget for CY 2021 of the municipality, which was passed and approved by their Sangguniang Bayan through Appropriation Ordinance No. 5, S-2020 dated December 7, 2020 amounting to P116,936,353.00;

WHEREAS, the development fund amounting to P22,537,322.60 which is allocated for development projects is 20% of the LGU's IRA (P112,686,613.00) for CY 2021. This is in accordance with Section 287 of RA 7160;

WHEREAS, the identified development programs/projects to be funded by the 20% of IRA conforms with the DBM-DOF-DILG Joint Memorandum Circular No. 1, dated November 4, 2020 entitled "Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs/projects/activities identified to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to P5,846,817.65 were based on Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). Further, the LDRRM Plan of the municipality was reviewed and a certification was issued by the Office of Civil Defense (OCD) dated November 4, 2019;

WHEREAS, the municipality has also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;
