**RESOLUTION NO. 162-2022**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2021 OF BASISTA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P1,273,000.00, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2021 involving total appropriations of P1,273,000.00 which was enacted on December 30, 2021 through Appropriation Ordinance No. 04, Series of 2021;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993; and

2. That the grant of Other Personal Benefits (Service Recognition Incentive) to government employees for FY 2021 shall be subject to the provisions of Administrative Order No. 45 dated December 24, 2021 by the Office of the President and Budget Circular No. 2021-4 dated December 28, 2021.


