APPROVING RESOLUTION NO. 087-2021 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED “APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF LABRADOR, PANGASINAN FOR CY 2021”

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Resolution No. 087-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

WHEREAS, the Local Development Council of Labrador, Pangasinan had identified endorsed to the Sangguniang Bayan for approval the Revised Annual Investment Program CY 2021 on November 24, 2021 through MDC Resolution No. 005, Series of 2021;

WHEREAS, the 2021 AIP of the Municipality of Labrador was revised to integrate the Supplemental Local Risk Reduction and Management Fund Investment Plan (LDRRMFIP) prepared and endorsed by the LDRRM Council through MDRRMC Resolution No. 001, S-2021 on November 22, 2021. The LDRRMFIP includes COVID-19 related programs and disaster reduction and mitigation projects to be funded from the municipality’s unexpended balances of their LDRRMF CY’s 2016 and 2017 (Trust Fund) in the amount of P3,814,306.23;


