APPROVING RESOLUTION NO. 291, S-2020 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED “APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 11 WITH THE CY 2020 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NUMBER 10 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 291, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Asingan, Pangasinan has formulated the municipality’s Supplemental Annual Investment Program No. 10 and endorsed thru MDC Resolution No. 11, S-2020 dated December 29, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Supplemental Annual Investment Program with an investment requirement of P548,500.00 covers the grant of gratuity pay to contract of service and job order workers in the municipality;

WHEREAS, the Sangguniang Bayan on December 29, 2020 enacted Supplemental Budget No. 8 thru Appropriation Ordinance No. 10, S-2020 to support the implementation of the Supplemental Annual Investment Program of the municipality;


