RESOLUTION NO. 168-2019

DECLARING MUNICIPAL ORDINANCE NO. 4, S-2018 OF SANGGUNIANG **BAYAN OF** PANGASINAN, **ENTITLED** "AN **ORDINANCE** PROVIDING FOR AN ECOLOGICAL SOLID WASTE MANAGEMENT, PRESCRIBING FEES FOR SOLID **MANAGEMENT** WASTE SERVICES, **DECLARING** CERTAIN **ACTS PROHIBITED** AND **PROVIDING** PENALTIES. THEREFORE" AS WITHIN CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Municipal Ordinance No. 4, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16, 17 (a) (2) (vi), 447 (1) (iii) (vi) of RA 7160; Article II on State Policies of the 1987 Philippine Constitution; RA 8749 or the Clean Air Act of 1999; RA 9003 or the Solid Waste Management Act; RA 9275 or the Clean Water Act;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the provisions of Sections 59 (c) and 511 (a) of RA 7160;
