APPROVING RESOLUTION NO. 2020-60 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED "APPROVING ANNUAL SUPPLEMENTAL INVESTMENT PROGRAM NO. 2020-04 OF THE SUPPLEMENTAL BUDGET NO. 2020-04 OF THE MUNICIPALITY OF SAN MANUEL, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Resolution No. 2020-60 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Asingan, Pangasinan has formulated the municipality's Supplemental Investment Program No. 4 and endorsed thru MDC Resolution No. 06, S-2020 dated December 21, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Supplemental Investment Program with an investment requirement of P5,726,263.21 covers the provision of Service Recognition Incentive benefits for municipal officials and employees and fund augmentation for capital outlay of executive and legislative departments;

WHEREAS, the Sangguniang Bayan on December 29, 2020 enacted Supplemental Budget No. 4 thru Appropriation Ordinance No. 05, S-2020 to support the implementation of the Supplemental Investment Program of the municipality;


