RESOLUTION NO. 17-2019

DECLARING MUNICIPAL ORDINANCE NO. 09, S-2017 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING MARINE PROTECTED AREAS (MPAs) IN THE MUNICIPAL WATERS OF DASOL, PANGASINAN PARTICULARLY IN BARANGAY MACALANG, REGULATING ANY FORM OF ACTIVITIES WITHIN THE MPAs AND PROVIDING PENALTIES THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Dasol, Pangasinan submitted its Municipal Ordinance No. 09, Series of 2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 17 (b) (2) (i) and 447 (a) (5) (iii) of RA 7160; Article II, Section 16 and Article XII, Section 2 of the 1987 Philippine Constitution; and Section 16 of RA 8550 or the Philippine Fisheries Code of 1998;

WHEREAS, subject ordinance shall take effect after the requirements set forth in Sections 59 and 511 (a) of RA 7160 has been complied with by the Sangguniang Bayan;


