APPROVING RESOLUTION NO. 2019-211 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 2, CY 2019 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2019-211 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Mangaldan, Pangasinan has prepared the municipality’s Supplemental Investment Program No. 2 for CY 2019. This was endorsed by the Council thru MDC Resolution No. 2, S-2019 dated December 11, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 2019-211 dated December 18, 2019;

WHEREAS, said Supplemental AIP is intended for the granting of the One-Time Service Recognition Incentive (SRI) for FY 2019 to qualified personnel of the LGU amounting to a total of P2,016,000.00;

WHEREAS, funding for this Supplemental AIP is embodied in Supplemental Budget No. 2, CY 2019, and enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2019-134 dated December 18, 2019;
