APPROVING RESOLUTION NO. 2021-288 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 9, CY 2021 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2021-288 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Municipal Development Council-Executive Committee of Mangaldan, Pangasinan prepared their Supplemental Annual Investment Program (SAIP) No. 9 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on December 29, 2021 through MDC Resolution No. 8, Series of 2021;

WHEREAS, said Supplemental Annual Investment Program which has a total investment requirement of P1,705,000.00, covers the granting of gratuity pay to contract of service, job order workers and hired service employees of the LGU;

WHEREAS, funding for the Supplemental AIP will be sourced from the savings of the LGU as embodied in their Supplemental Budget No. 8, FY 2021, which was enacted by their Sangguniang Bayan on December 29, 2021 through Appropriation Ordinance No. 2021-29;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;
