## PROVINCIAL ORDINANCE NO. 172-2013

## AN ORDINANCE TRANSFERRING THE POSITION OF ENGINEER III FROM THE OFFICE OF THE PROVINCIAL HEALTH OFFICER TO THE OFFICE OF THE PROVINCIAL ENGINEER

WHEREAS, Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirement and financial capability, subject to the minimum standard and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 468 (a) (viii) of the same Code provides that the Sangguniang Panlalawigan has the power to determine the positions and salaries including allowances and other emoluments and benefits of employees of the provincial government;

WHEREAS, in the preparation of the Annual Budget for Calendar Year 2014, Honorable Governor Amado T. Espino, Jr. proposed that the position of Engineer III under the Office of the Provincial Health Officer be transferred to the Office of the Provincial Engineer who will take charge in the maintenance/ repair of fixtures, facilities and buildings within the capitol compound;

WHEREAS, the Committees on Appropriations, Ways and Means and Human Resources and Development, after a study of the proposed organization of the provincial government of Pangasinan, find it meritorious to realign and transfer some plantilla positions in order that the various offices concerned could deliver more effective and efficient duties and responsibilities;

> **NOW, THEREFORE,** on joint motion of SP Member Clemente B. Arboleda, Jr., Chairman of the Committee on Appropriations, Economic Affairs and Ways and Means, and SP Member Angel M. Baniqued, Jr., Chairman of Human Resources and Development, duly seconded,

Be it enacted by the Sangguniang Panlalawigan in session assembled that:

Section. 1 The position of Engineer III in the Office of the Provincial Health Officer is hereby transferred to the Office of the Provincial Engineer.

Section 2. The corresponding salaries and other benefits of the abovementioned position shall be appropriated in the General Fund Annual Budget of the province for Calendar Year 2014.

Section 3. Effectivity. This Ordinance shall take effect on January 1, 2014.
