APPROVING RESOLUTION NO. 2021-568 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 5 FOR THE CALENDAR YEAR 2021 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2021-568 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, on November 29, 2021 the Local Development Council of Balungao, Pangasinan has identified programs/projects to be funded from CY 2018 & 2019 municipality's share from Tobacco Excise Tax. These are embodied in the Supplemental Investment Program No. 5 which was endorsed to the Sangguniang Bayan for approval through MDC Resolution No 2021-09;

WHEREAS, the Supplemental Investment Program No. 5 covers the implementation of development projects that are consistent with Local Budget Memorandum Nos. 83 & 84, both dated November 22, 2021;

WHEREAS, on December 1, 2021, the Sangguniang Bayan enacted Supplemental Budget No. 3 through Appropriation Ordinance 2021-04 to support the implementation of the Supplemental Investment Program No. 5 for CY 2021 of the municipality;
