APPROVING RESOLUTION NO. 21-68 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN, ENTITLED, "APPROVING THE LOCAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2021-5 EMBODYING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 3 FOR FY 2021 OF THE MUNICIPALITY OF STA. MARIA"

WHEREAS, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its Resolution No. 21-68 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, on December 3, 2021, the Local Development Council of Sta. Maria, Pangasinan endorsed to the Sangguniang Bayan for approval the Supplemental Annual Investment Program No. 3 (SAIP No. 3) for FY 2021;

WHEREAS, the Supplemental Investment Program No. 3 contains programs/projects to be funded by the proceeds from Loan from Land Bank of the Philippines in the amount of P149,000,000.00;

WHEREAS, the Local Development Investment Program for FY 2021-2023 was updated to include the programs and projects included in the Supplemental Investment Program No. 3;

WHEREAS, the Sangguniang Bayan also enacted Supplemental Budget No. 3 for Calendar Year 2021 through Appropriation Ordinance No. 21-08 dated December 17, 2021 to support the implementation of the Supplemental Annual Investment Program (SAIP) No. 3 of the Municipal Government of Sta. Maria;


