APPROVING RESOLUTION NO. 19-115 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 4 FOR CALENDAR YEAR 2019 OF THE MUNICIPALITY OF LAOAC, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Resolution No. 19-115 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Laoac, Pangasinan has formulated the municipality’s Supplemental Investment Program No. 4 for CY 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 2019-04 dated November 8, 2019. The Sangguniang Bayan approved the Supplemental Investment Program No. 4 on November 25, 2019 thru Resolution No. 19-115. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 4 of the municipality with an investment requirement amounting to P2,394,503.73 covers full the implementation of 4th Tranche Salary Compensation Adjustment of the municipal officials and employees;

WHEREAS, on November 25, 2019, the Sangguniang Bayan of Laoac enacted Supplemental Budget No. 1 thru Appropriation Ordinance No. 19-003 to support the implementation of the Supplemental Investment Program No. 4 of the municipality;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;


