## PROVINCIAL ORDINANCE NO. 181-2014

AN ORDINANCE TRANSFERRING AND/OR RECLASSIFYING SOME PLANTILLA POSITIONS IN THE DIFFERENT OFFICES IN THE PROVINCIAL GOVERNMENT

WHEREAS, Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirement and financial capability, subject to the minimum standard and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 468 (a) (viii) of the same Code provides that the Sangguniang Panlalawigan has the power to determine the positions and salaries including allowances and other emoluments and benefits of employees of the provincial government;

WHEREAS, in the preparation of the Annual Budget for Calendar Year 2015, Honorable Governor Amado T. Espino, Jr. proposed that some of the provincial employees should be transferred from their mother units to the Office where they are actually and presently assigned in order to cope with the plans, programs and activities of the present administration;

WHEREAS, the Committees on Appropriations, Ways and Means and Human Resources and Development, after a study on the proposed organization of the provincial government of Pangasinan, find it meritorious to transfer and/or reclassify some plantilla positions in some provincial departments in order that the various offices concerned could be more dynamic and deliver more effective and efficient duties and responsibilities;

**NOW, THEREFORE,** on joint motion of SP Member *Clemente B. Arboleda, Jr.* Chairman of the Committee on Appropriations, Economic Affairs and Ways and Means, and SP Member *Angel M. Baniqued, Jr.*, Chairman of Human Resources and Development, duly seconded,
