AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH VARIANCE TRADING CORPORATION FOR THE PROVISION OF HOSPITAL EQUIPMENT UNDER PUBLIC-PRIVATE PARTNERING SCHEME FOR THE PANGASINAN PROVINCIAL HOSPITAL


