APPROVING MUNICIPAL RESOLUTION NO. 2020-196 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 04 FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF ALCALA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Resolution No. 2020-196 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Alcala, Pangasinan has formulated the municipality's Supplemental Investment Program No. 04 and endorsed thru MDC Executive Committee Resolution No. 2020-06 dated December 22, 2020 to the Sangguniang Bayan for approval. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 04 with an investment requirement amounting to P1,200,000.00 covers the provision of Service Recognition Incentive benefits for municipal officials and employees;

WHEREAS, on December 23, 2020, the Sangguniang Bayan enacted Supplemental Budget No. 03 thru Appropriation Ordinance No. 2020-04 to support the implementation of the Supplemental Investment Program No. 04 of the municipality;
