**PROVINCIAL RESOLUTION NO. 186-2019**

**RATIFYING THE AMENDMENT TO THE APPROVED P900 MILLION OMNIBUS TERM LOAN FACILITY ENTERED INTO AND SIGNED BY AND BETWEEN THE PROVINCE OF PANGASINAN, REPRESENTED BY HONORABLE GOVERNOR AMADO I. ESPINO III, AND THE LAND BANK OF THE PHILIPPINES, REPRESENTED BY ITS PRESIDENT/CEO, CECILIA C. BORROMEO THRU ITS ASSISTANT VICE PRESIDENT/HEAD, PANGASINAN LENDING CENTER, JAIME S. CRUZ, JR.**

**WHEREAS**, the Sangguniang Panlalawigan has approved Provincial Ordinance No. 222-2019, dated January 21, 2019, entitled “An Ordinance Authorizing the Proposed Drawdown from the Nine Hundred Million Pesos (P900 M) Approved Omnibus Term Loan Facility of the Province of Pangasinan to Fund the Local Infrastructure and Other Socio-Economic Development Projects”;


