PROVINCIAL RESOLUTION NO. 189-2019

**ADOPTING THE CONTINGENCY PLAN FOR TYPHOONS
AND FLOODINGS IN THE PROVINCE OF PANGASINAN**

WHEREAS, Republic Act No. 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010 provides that provincial, city and municipal Disaster Risk Reduction and Management Offices (DRRMOs) or Barangay Disaster Risk Reduction and Management Councils (BDRRMCs), in coordination with concerned national agencies and instrumentalities, shall facilitate and support risk assessments and contingency plan activities at the local level;

WHEREAS, the Sangguniang Panlalawigan is in receipt of Executive Order No. 0114, Series of 2018, dated September 28, 2018, mandating the formulation of Contingency Plan for Typhoons and Floodings in the Province of Pangasinan;

WHEREAS, the Provincial Government of Pangasinan, through the Provincial Disaster Risk Reduction and Management Office, in coordination with various national government agencies, other provincial government department offices, academe, civil society organizations and private sector representatives, has formulated the Contingency Plan for Typhoons and Floodings in the Province of Pangasinan which presents a risk assessment that involves information on the hazards, vulnerabilities and exposures in Pangasinan, as well as the current capacities to respond in a real worst case scenario;

WHEREAS, typhoon and flooding are two of the most threatening disaster scenarios in the Province upon conduct of risk analysis;

WHEREAS, the Contingency Plan aims to provide effective, efficient, timely and well-coordinated response mechanism in the event of the occurrence of typhoon and flooding;

WHEREAS, the Contingency Plan also identifies other possible scenarios and all the response arrangements including standby resources, the response actors and their respective roles and responsibilities;


WHEREAS, the Sangguniang Panlalawigan fully supports the Contingency Plan of the Province for Typhoons and Floodings as it can help protect lives and ensure the availability of resources and likewise establishes a mechanism for rapid decision-making based on authority, responsibility and accountability;

WHEREFORE, in view of the foregoing, on motion of SP Member Liberato Z. Villegas, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled to adopt, as it is hereby adopted, the Contingency Plan for Typhoons and Floodings in the Province of Pangasinan;
