**RESOLUTION NO. 191-2020**

**APPROVING RESOLUTION NO. 2019-051 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL AIP PURSUANT TO APPROPRIATION ORDINANCE NO. 2019-003 OF THE MUNICIPALITY OF TAYUG, PANGASINAN INVOLVING AN AMOUNT OF SIX MILLION NINE HUNDRED THIRTY SEVEN THOUSAND TWO HUNDRED FOUR PESOS AND 90/100 (P6,937,204.90)”**

**WHEREAS**, the Sangguniang Bayan of Tayug, Pangasinan submitted its Resolution No. 2019-051 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Tayug, Pangasinan has formulated the municipality’s Supplemental Investment Program No. 2 for CY 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 2019-06 dated December 2, 2019. This was approved by their Sangguniang Bayan on December 16, 2019 thru Resolution No. 2019-051. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the Supplemental Investment Program of the municipality with an investment requirement amounting to P6,937,204.90 covers the fund augmentation for the maintenance and other operating expenses of the executive and legislative department and implementation of the electrification program of the municipality;

**WHEREAS**, to support the implementation of the project embodied in Supplemental Investment Program No. 2 of the municipality, the Sangguniang Bayan of Tayug, Pangasinan has enacted Supplemental Budget No. 2 through Appropriation Ordinance No. 003-2019 dated December 16, 2019;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
