## PROVINCIAL ORDINANCE NO. 194-2015

**AN ORDINANCE AUTHORIZING THE PROPOSED SECOND DRAWDOWN OF THE PROVINCE OF PANGASINAN IN THE AMOUNT OF NINETY-TWO MILLION FOUR HUNDRED SEVENTY THOUSAND PESOS (P92,470,000.00) TO FUND VARIOUS HEAVY CONSTRUCTION EQUIPMENT TO BE PURCHASED BY THE PROVINCE**

BE IT ENACTED, as it is hereby enacted by the Sangguniang Panlalawigan, in session assembled that:

**SECTION 1.** The Provincial Governor, in representation of the Province, hereinafter referred to as the "Province", is hereby authorized to enter into Term Loan with the Land Bank of the Philippines in accordance with Section 297 of Republic Act No. 7160 or the Local Government Code, in the amount of **NINETY-TWO MILLION FOUR HUNDRED SEVENTY THOUSAND PESOS (P92,470,000.00)** under the terms and conditions herein set forth and such other terms and conditions as may be agreed upon with any person, corporation or entity for the purpose of funding priority project/s, and subject to the requirements under Section 123 of Republic Act No. 7653 as implemented by the Bangko Sentral ng Pilipinas Circular No. 402. In this connection, the Provincial Governor shall have full power and authority to represent the Province in negotiating the terms and conditions for the said drawdown and in signing, executing and delivering such agreements, contracts, deeds, papers and documents as may be necessary and proper for the full and total implementation of the authority herein granted.

**SECTION 2.** The said priority project herein specified as for the Purchase of Various Heavy Construction Equipment is hereby certified to be local infrastructure and other socio-economic development project in accordance with the approved local development plan and public investment program for the period CY 2014 or the annual public investment program for the current year 2015 of the Province of Pangasinan.

**SECTION 3.** Consistent with the covering loan agreement contract, deeds and assignment, mortgage contracts, and such other agreements as may be entered into by the Province in connection with the borrower, the features, terms and conditions shall be as follows and are hereby approved:

Term: 10 years  
Manner of Payment: Quarterly  
Interest: Quarterly in arrears  
Principal: Equal quarterly payments  
Interest Rate: 5.5% fixed for 3 years subject to quarterly repricing from 4<sup>th</sup> year onwards based on prevailing prime rate plus minimum spread of 1%  
Collateral/Guarantee/Security: Assignment of IRA

**SECTION 4.** The project listed above and its corresponding amount to be financed by the loan from the Land Bank of the Philippines is hereby certified to be necessary, self-liquidating, income producing development project, in accordance with local development plan and public investment program for Calendar Year 2014/2015 of the Province of Pangasinan.

**SECTION 5.** The Province hereby appropriates the entire proceeds of the borrowing exclusively to finance the said project and other financial obligations relative thereto.

**SECTION 6.** Any Ordinance or parts thereof, inconsistent with this enactment is hereby repealed or amended accordingly.

**SECTION 7.** This Ordinance shall take effect upon its publication and compliance with all procedures required under Republic Act No. 7160 of an ordinance for its validity, including the affixation of signatures of the Sangguniang Panlalawigan Members, in concurrence thereto, composing at least a majority thereof, out of the total 15 members, on all pages of this Ordinance.

**RESOLVED FURTHER,** that copies of this Ordinance be furnished the Honorable Governor, Amado T. Espino, Jr., the Provincial Accountant, the Provincial Auditor, all of the Province of Pangasinan, Land Bank of the Philippines, Bangko Sentral ng Pilipinas and other concerned agencies, for their information and appropriate action.
