DECLARING RESOLUTION NO. 195, S-2020 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED “ADOPTING THE COMPREHENSIVE LAND USE PLAN 2019-2028 OF THE MUNICIPALITY OF SAN FABIAN, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 195, S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, and Provincial Land Use Committee, have conducted initial review and study on said resolution and found out that the same was enacted pursuant to Section 447 (a) (2) (vii) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Zoning Ordinance of San Fabian, Pangasinan had undergone the technical review by the Provincial Land Use Committee (PLUC) of the Province of Pangasinan pursuant to the guidelines of Section 2 (b) of Executive Order No. 72, S-1993 and its implementing guidelines;

WHEREAS, the PLUC certified that the Municipality had incorporated in the final draft of the CLUP its recommendations and suggestions;
